
Global media hits

Damp consumer guide and Design & specification guidance


Joanne Williams, Building Surveying & Building Control PGP, helped review the Damp and mould consumer guide. A comprehensive online resource available on RICS.org

Members also serve on the Landlord & Tenant Review group, Upward only Rent Review Group and Entry & Assessment review groups




Land agreements standard and flooding paper

Home survey & Retrofit standards


Kate Charrington and Prof. Richard Fitton, Residential PGP, are members of the Home Survey Standard and Residential Retrofit expert working groups.

James Ginley, Residential PGP, was part of the Expert Working Group for the Secured lending valuation of properties with cladding. The new edition will be published later in December.





- This year's Building Surveying Conference was particularly successful attracting over 350 attendees.
- Helen McKeown, Building Survey and Building Control PGP Interim Chair, made for a great chair for the day. As the largest in person conference in the UK we had 29 speakers on the day.

RICS Commercial Property and Valuation conferences



- Commercial Property PGP Roddy Houston Chair, Jonathan Theobald Vice Chair, Nella Pang and Yulia Pak Worked with the Portfolio Manager on the RICS Commercial Property Conference with Nella Chairing on the day.
- With a longer lead time and joint effort on speaker outreach, content and promotion, the team built real momentum which resulted in the event selling out for the first time in recent years, with delegate bookings more than doubling from 2024.



- The UK&I Valuation Conference this year ran as a digital conference Chaired by Nick Knight, Valuation PGP Chair.
- We achieved a 22% year on year increase in attendance. This has given us the confidence to continue this product as a digital offering, with the goal to grow this audience further next year.

- The programme delivered a stellar lineup of expert speakers, with Chris Curtis MP as our keynote speaker and representation from key member firms.




- The Land and Natural Resources PGP was engaged with the RICS Minerals and Waste Conference; they were involved in the programme development and Kate Young chaired the day.
