Senior judges



Hon'ble Mr. Justice V.C. Daga (Retd.)

Senior Advocate, Supreme Court of India

Former Judge, Bombay High Court

Enrolled as Advocate in 1972, Justice Daga practised mainly before Nagpur Bench of Bombay High Court. Appeared regularly before Supreme Court of India and various other courts primarily in Civil, Constitutional, Labour, Banking, Service and Excise related matters. Represented Hon'ble Chief Justice, Registrar of Bombay High Court and District & Sessions Judge in the Vidarbha region before the Nagpur Bench in matters filed against them. Was Standing Counsel /Panel Counsel for various private and public-sector banks, statutory, government, semi-government organisations and various leading industrial houses of Vidarbha region. Was Honorary Secretary, High Court Bar Association (HCBA) (1983 to 1986) and later went on to become its President (1996 to 1999). Was Senator, Nagpur University (1989 to 1995) and later was also elected as the Dean, Faculty of Law, Nagpur University (1989 to 1992). Was a Member, Executive Council/Management Council of the Nagpur University (1992 to 1995). Associated with various social and educational institutions such as Central India Institute of Medical Sciences (CIIMS) and G.S.College of Commerce and Economics, Nagpur. Was a Judge of the Bombay High Court (December 1999 to February 2011). Designated as Senior Advocate by Supreme Court of India in 2011, now mainly practises before the Supreme Court. Also acts as Arbitrator in domestic & international arbitrations. Headed the HPC constituted by SEBI for settlement of disputes. Chairman of committee constituted by Bombay High Court to hear and decide investor claims arising from disputes pertaining to transactions on NSE. Chairman of fees fixation committee for Krishna Vishwa Vidhyapeeth (Deemed University), Karad.

Hon'ble Mr. Justice Rajiv Sahai Endlaw (Retd.)

Undertook LLB from Campus Law Centre, Delhi University and enrolled as an advocate with the Bar Council of Delhi in July 1982. Initially joined a solicitor's firm for 3 years and thereafter practiced law in the Delhi High Court and the subordinate courts, mainly on the original side in the fields of real estate, family, civil and arbitration laws. Appointed as Additional Judge of Delhi High Court in 2008 and became Permanent Judge in 2011.



Hon'ble Mr. Justice M.L. Mehta (Retd.)



Justice Mehta has over four decades of judicial experience and has served as both a high court and district court judge in Delhi. He has presided over all jurisdictions ranging from trial/original, appellate, writ, revenue, taxation, criminal, civil, and commercial, among others. Justice Mehta has been appointed as an arbitrator by different High Courts and the Supreme Court of India and is one of India's preeminent arbitrators for complex civil, commercial, multi-party, and high stake cases. He is empaneled on institutions, such as the Indian Council of Arbitrators and the ASSOCHAM International Council of Alternate Dispute Resolution. He has served as an arbitrator in a wide variety of arbitrations involving investments, trade, construction, oil and gas, banking, corporate, distributorship, franchising, licensing, and general commercial matters and has also mediated high stake disputes, including disputes by and against the departments of the government.

Justice Mehta is a fellow of Weinstein International ADR (USA) and has been awarded as Outstanding International Commercial Dispute Resolver by Jams Foundation (USA). Justice Mehta has established Delhi Dispute Resolution Society (Rgd) as joint venture of Delhi High Court and Government of Delhi, and established nine Mediation and Conciliation Centres in Delhi which he oversees and supervises as its Founder Chairman. Since retirement from Delhi High Court, he is designated Senior Advocate Supreme Court and also empanelled on Delhi International Arbitration Centre, IAMC and other Institutions of India and abroad.

Hon'ble Mr. Justice Jayant Nath (Retd.)



Practised as an Advocate in Supreme Court of India, Delhi High Court, various Tribunals including Central Administrative Tribunal (Principal Bench), New Delhi, National Consumer Disputes Redressal Commission etc. Has been Standing Counsel for DESU/DVB from 1995 to 2002. Represented various Public Sector Undertakings, Banks etc. Was trained as Mediator by the Delhi High Court Mediation and Conciliation Centre and conducted various mediations therein. Conducted cases relating to various laws e.g. Service, Labour, Arbitration, Constitution and Administrative Law. Was designated as Senior Advocate by the High Court of Delhi in May 2006. Appointed as Additional Judge of Delhi High Court in April, 2013 and became permanent Judge in March 2015 (F/N). Retired in November 2021. Thereafter has been practising as Senior Advocate in the Supreme Court. Has been appointed as Arbitrator in large number of cases. Appointed as pro-tem Chairperson, Delhi Electricity Regulatory Commission, New Delhi in August 2023.

Hon'ble Mr. Justice K.S. Radhakrishnan (Retd.)

Justice Radhakrishnan enrolled as Advocate in 1973 and practised in the High Court of Kerala and Subordinate Civil Courts at Ernakulam. Justice Radhakrishnan functioned as a Standing Counsel for several educational and social organizations, including Cochin University of Science and Technology, State Bank of India, State Bank of Travancore, Kerala State Cooperative Rubber Marketing Federation and State Trading Corporation of India.

Justice Radhakrishnan was appointed as Additional Judge of the Kerala High Court in 1995 and Permanent Judge in 1996. Shri Radhakrishnan has also remained as President of Kerala Judicial Academy, Chairman, Lakshdweep Legal Services Authority, Former Chancellor, National University of Legal Studies (NUALS), Executive Chairman of Indian Law Institute, Kerala Branch and Chairman, Governing Council of Indian Law Reports. Shri Radhakrishnan was acting Chief Justice of High Court of Kerala from March 19, 2005 till April 27, 2005, from January 1, 2006 to January 22, 2006 and from January 24, 2007 to May 17, 2007.

Elevated as Chief Justice of High Court of Jammu & Kashmir and assumed charge of office in 2008 and also functioned as Patron-in-Chief of the Jammu and Kashmir Legal Services Authority.

Shri Radhakrishnan assumed charge as the Chief Justice of High Court of Gujarat in 2008. Elevated as Judge, Supreme Court of India in November 2009 and retired in May 2014. Currently he is a member of the Commonwealth Secretariat Administrative Tribunal (CSAT) London and also of the Permanent Court of Arbitration Hague, Netherlands.



Hon'ble Mr. Justice G.S. Sistani

Enrolled as an Advocate with the Bar Council of Delhi in 1982. Practiced law in the High Court of Delhi and the Supreme Court of India in commercial, civil, writ, original and company jurisdiction. He also appeared before the Monopolies and Restrictive Trade Practices Commission (now the Competition Commission), Debt Recovery Tribunal and Arbitrators. Dealt with cases relating to constitutional law, banking, taxation, real estate, administration, corporate, commercial Services etc.

Represented Government of Delhi in a variety of cases relating to Directorate of Education, Excise, Service Matters etc. Had represented the Delhi Development Authority and was the Standing Counsel for Punjab & Sind Bank. Appeared for several private and nationalized banks, public sector undertakings and multinational companies. Was appointed Amicus Curiae in several cases by the High Court and worked pro bono for the Delhi High Court Legal Services Committee.



Elevated as Additional Judge of the High Court of Delhi in May 2006. Appointed as Member of the Overseeing Committee, Delhi High Court Mediation and Conciliation Centre in 2014 and thereafter its Chairperson since 2017 till March 2020.


Brigadier Girish Joshi
