Team Awards

Professional Consultancy Service Team of the Year - Construction

Nominated team should be a construction consulting team, which is providing quantity surveying, project management services, life cycle project consulting etc.

Research Team of the Year

Major functions of the nominated team must focus on researching land, infrastructure, construction, real estate, Project construction management, facility operation, maintenance management, and all built environment fields and contribute to research reports, white papers or books regularly, on which they offer consultancy to clients.

Professional Consultancy Service Team of the Year-Real Estate

Nominated team should be a real estate consulting team, which is providing strategy consulting, economy valuation, building surveying, due diligence, transaction service, asset securitization, risk management services etc. in real estate.

Facilities Management Team of the Year

Nominated team may be a service provider or the inhouse team of a facility owner.

Nomination must cover one project or initiative which must cover the occupier's interest of the property.

Emphasis may be placed on how the property has been managed with measurable outcomes and achievement as described by the judging criteria.

Projects Awards

Construction Project of the Year

The award recognizes construction projects that demonstrate outstanding achievement in the areas of delivery model, project implementation and application of the latest technology.

For the purpose of this award, construction means any project or program that delivers essential properties and facilities in connection with commercial real estate (office building, shopping centers, mix-use), transport systems, (road, rail, docks and airports), emergency services, healthcare (hospitals and medical facilities), supply projects for power generation, water or sewage treatment, sea defences and information technology networks etc.

Nomination must cover one project that satisfies the completion date requirement in the "Application and eligibility".

Nominator can be the owner, contractor or the main consultancy company of the project.

Industrial Real Estate Project of the Year

This award honors an outstanding industrial parks, industries, logistics and warehousing, and data center projects, including individual projects or group projects, new construction or renovation projects.

We are looking for evidence of a successful residential project in market positioning, development, construction, selling, quality controlling etc.

Nomination must cover one project that satisfies the completion date requirement in the "Application and eligibility".

Nominator can be the developer or the service provider.

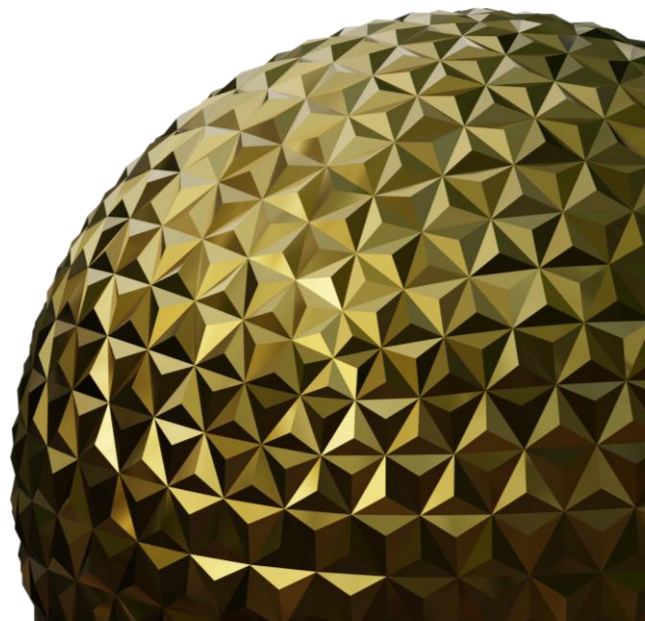
Commercial Property Project of the Year

This award honors an outstanding commercial property development whether retail, office, leisure, culture, tourism, long-term rental apartment or mixed use.

We are looking for evidence of a commercially successful project in market positioning, development, operation and management.

Nominated projects should starting use within the date specified in the "application and eligibility" rules or achieve significant success in operation through innovative management measures during the period. Projects applying for operational management achievements should be built/rebuild and open within 3 years of the application deadline.

Nominator can be the project owner, developer or the service provider.



Projects Awards

Urban Regeneration Project of the Year

Nomination must cover one project which has conserved or improved the built or natural environment in a way that has contributed to the viability of the area

Nomination should highlight professionalism, value and improvement, such as any breakthrough in respective field.

Nomination must cover one project that completes major renewal work or be commissioned and satisfies the completion date requirement in the "Application and Eligibility" by demonstrating the success of the renewal.

Nominated team may be an in-house team of a property owner or a service provider.

Best BIM Application of the Year

This award will recognize outstanding BIM application in different stages of project life cycle, such as investment decision-making, design, bidding and procurement, construction, operation and maintenance and renovation, etc.

Nomination must cover one project that satisfies the completion date requirement in the "Application and eligibility".

Nominator could be from the contractor, the BIM consultancy company or the owner of project.

Proptech Innovation Achievement of the Year

This award will recognize innovative technologies that create efficiency and value in process of buying, selling, leasing, marketing, operation management and finance in various space assets, including but not limited to Internet.

Digitalization, AI, IoT, 5G, VR, blockchain and other applications in the real estate industry.

Construction technology innovation: including but not limited to measures such as innovation in building materials, construction techniques, and construction equipment.

No time limit for nominated technology, but it is required to provide significant project applications or technical achievements satisfies the completion date in the "Application and eligibility".

Nominator could be technology developer or user of customized technology but must be declared in a consortium with the technology developer.

Best Deal of the Year

This award will recognize outstanding and influential transaction of China Mainland from 2024-2025, includes leasing, buying and selling transaction.

Nominated transaction must be from a deal which satisfies the completion date requirement in the "Application and eligibility".

Nominator can be parties in transaction or transaction service provider.

Sustainability Achievement of the Year

This award will recognize outstanding sustainability achievements in construction or operation process of real estate and infrastructure project, including but not limited to green buildings, application of energy conservation and environmental protection technologies, carbon reduction, environment, society and governance, etc.

Nomination should outline an overview of sustainable goals achieved and difficulties or methods overcome

The campaign and achievement must be from a project which satisfies the completion date requirement in the "Application and eligibility".

The nominated project with green building related certification will be an advantage.

Nominator could be from project owner, developer, contractor or service provider.

Real Estate Financing Innovation Achievement of the Year

This award will recognize financing and other financial achievements which promote a virtuous circle of capital in the process of real estate development, circulation and transaction, such as trust, real estate fund, asset securitization etc.

Nominated projects and achievements should satisfies the completion date requirement in the "Application and eligibility".

Nominators could be project principals or service providers such as managers, legal advisers, financial advisers, rating agencies, and evaluation agencies.



Individual Awards

Construction Professional of the Year

Presented to an outstanding individual for excellence in quantity surveying, project management, land or building surveying or building control. The Construction Professional of the Year award recognises achievement in construction projects during 2024-2025.

The successful candidate will demonstrate how their work has combined the highest professional, ethical and industry standards to deliver superior results and outcomes for clients and stakeholders.

Property Professional of the Year

Presented to an outstanding individual involved in valuation, property management, facilities management, valuation or acquiring/selling or leasing a commercial, industrial or retail property. The Property Professional of the Year award recognises achievement in property projects during -2025.

The selected professional will represent the highest professional ethics, demonstrate their use of standards in their day to day activities and embody the excellence expected of the recipient of such a prestigious award.

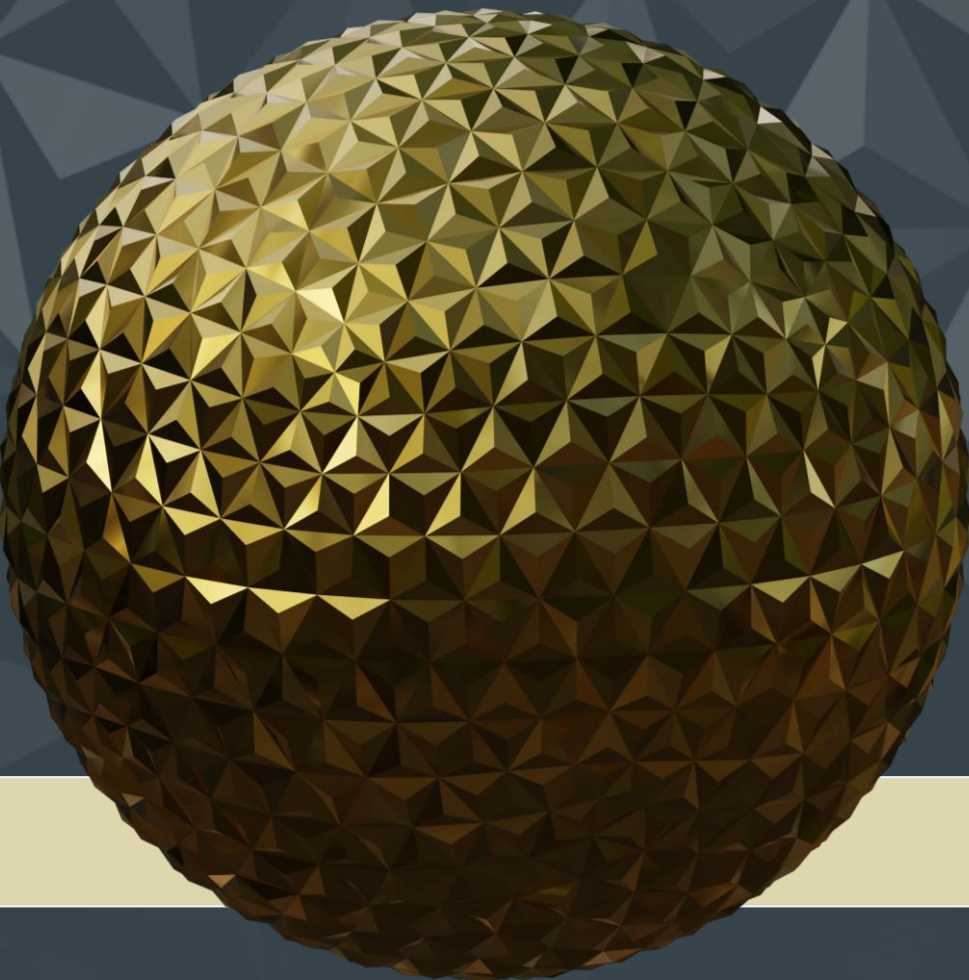
Lifetime Achievement Award
