The submitted report, cross-examination exercise and additional online interview assesses:

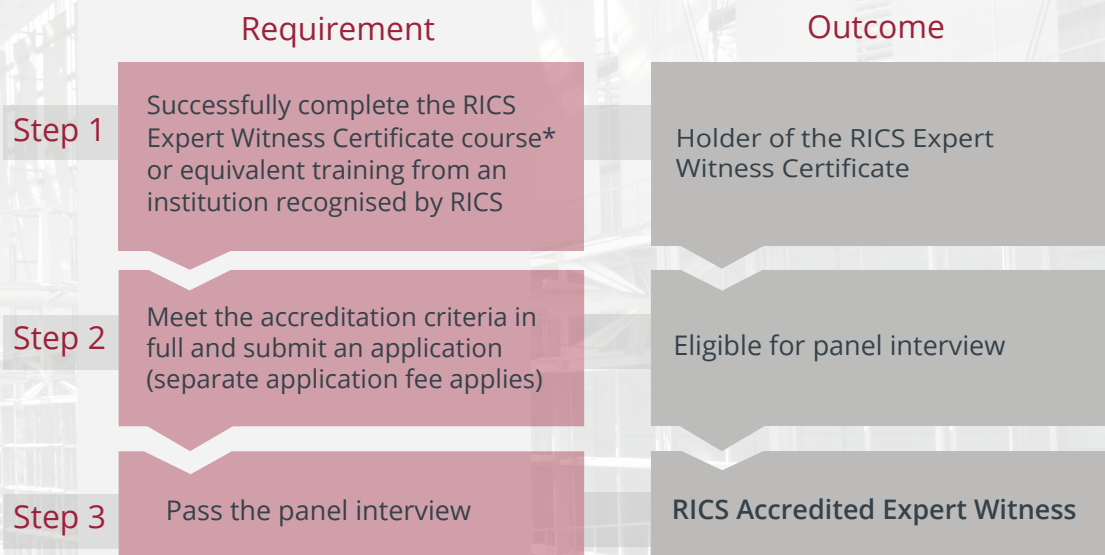
