Urban Decarbonization: Leveraging Nature-Based Solutions

The transformation of our buildings and urban landscapes to address the challenges of climate change and create more resilient cities is a pivotal and multifaceted challenge. In terms of policy, the new, recast Energy Efficiency Directive introduces a series of measures to help accelerate energy efficiency including embracing the “energy efficiency first” principle in the energy and non-energy policies.

This panel will look at nature-based solutions to make our cities more resilient, both at the level of individual buildings and building components, and at the wider level of the city. It will also explore regenerating urban environments through biodiversity and the solutions needed for the built environment to not only mitigate negative impacts but also utilize the opportunity of urban development for biodiversity regeneration.
