Why enter the Awards?

Each year the RICS Awards showcase the most inspirational initiatives and developments in land, real estate, construction, and infrastructure – and 2024 will be no different.

The awards are a perfect platform to highlight how the profession impacts local communities and the wider built and natural environment.

During May and June, we will host regional events to celebrate the achievements, and announce which projects from the 12 regions are going forward as a finalist to compete at October's national event.

Finalists and Award winners will have PR support from the RICS and the chance to be featured in online, print, and filmed content.

RICS Awards are highlighted on all our social media channels with over 260,000 followers on LinkedIn and an ever-growing myRICS global community.

Award winners will receive both hard-copy and digital RICS Awards marketing assets.

If you are considering entering the RICS UK 2024 Awards, please read the entry criteria below to make sure you are eligible and have the required documents to complete your entry. You can also plan and check the upcoming dates for the RICS UK Awards.

Who can enter?

We welcome all individuals, teams and organisations who meet the criteria of the relevant category to apply for the awards. It is important that all applicants review the entry guidelines and assessment criteria to ensure that their submission meets the necessary requirements. The RICS UK Awards 2024 are free to enter for RICS and non RICS Professionals.



How to enter?

Register an account. RICS Awards 2023 (awardsplatform.com)

Each submission must be accompanied by specific submission materials, which will be reviewed by the judges.

Your submission should include:

- Project Name –the project name provided should be clear as it will be used throughout the entire campaign. Example: RICS HQ, London
- Category you are submitting for.
- Nominator and Nominee contact details.
- Project address entries may involve a site visit.
- RICS Surveyor working on the project if applicable
- Main body of nomination –and connection to the judging criteria
- Up to 3 testimonials (PDF upload).
- Photographs of the nominated team/individual and project(s) referenced in the submission.
- Any other appropriate supporting material, such as technical documentation, media clippings, floor plans, etc.
- Your company logo.
- A 100-word summary of the nomination for marketing purposes what the project was and how the team/individual has showcased excellence (free text section within the form).

UK Regional

Project Awards

- 1. Nominations can be made by the nominee (team, company, or consortia) or a third party.
- 2. The project(s) which is the subject of a nomination must have been worked on within the 2023 calendar year, though not necessarily completed.
- 3. Nominations must be based on at least one but no more than three projects within the calendar year (nominating party to select).
- 4. A company may submit a joint nomination however, where a joint nomination is submitted a subsequent, stand-alone application from the same company and in the same category is not allowed.
- 5. Nominations must be submitted via the online submission form. Where multiple nominations are being submitted by the one organisation, a separate online submission form will need to be completed for each nomination.
- 6. Nomination must be accompanied by a 100-word summary in word file for marketing purposes.



- 7. Other relevant supporting materials/documents are optional but welcomed. These should be limited to a maximum of five additional pages of supporting material/documents and three testimonials, all in PDF format.
- 8. A logo must be provided as well as a photo of the team or individual nominated. This will be used during award presentation.
- 9. Information provided within the submission may be used by RICS for the purpose of the judging or promotion of the Awards. Any confidential information must be clearly stated within the submission.
- 10. The jury panel's decision on eligibility of the nominations shall be final and is non appealable.

UK National Awards

Team and/or Individual awards

- 1. Nominations should be made by a third person/entity but will be accepted from the nominee.
- 2. Nominations must be submitted via the online submission form. Where multiple nominations are being submitted by the one organisation, a separate online submission form will need to be completed for each nomination.
- 3. Nomination must be accompanied by a 100-word summary in word file for marketing purposes.
- 4. Other relevant supporting materials/documents are optional but welcomed, should be limited to a maximum of five additional pages of supporting material/documents and three testimonials, all in PDF format.
- 5. A logo must be provided as well as a photo of the team or individual nominated. This will be used during award presentation.
- 6. Information provided within the submission may be used by RICS for the purpose of the judging or promotion of the Awards. Any confidential information must be clearly stated within the submission.
- 7. The jury panel's decision on eligibility of the nominations shall be final and is non appealable.
- 8. The team and/or individual must have completed the RICS ethics module and have no regulatory
- 9. investigations outstanding or in progress

Special Category Awards

- 1. Nominated major projects must be located or operated in the UK.
- 2. Nominations can be made by the nominee (team, company, or consortia) or a third party.
- 3. Nominated major projects which is the subject of the nomination must have been worked on within the 2023 calendar year, though not necessarily completed.
- 4. Nominations must be based on at least one but no more than three projects within the calendar year (nominating party to select).
- 5. A company may submit a joint nomination however, where a joint nomination is submitted a subsequent, stand-alone application from the same company, on the same project(s) and in the same category is not allowed.



- 6. Nominations must be submitted via the online submission platform. Where multiple nominations are being submitted by the one organisation, a separate online submission will need to be completed for each nomination.
- 7. Nomination must be accompanied by a 100-word summary for marketing purposes.
- 8. Other relevant supporting materials/documents are optional but welcomed. These should be limited to a maximum of five additional photographs, three additional pieces of supporting material/documents and three testimonials. (Documents and testimonials should be in PDF format.)
- 9. A logo must be provided as well as a photo of the team or individual nominated. This will be used for marketing purposes and during award presentations.

Conditions of entry

Each entry will be subject to due diligence checks (including regulatory checks and online information searches) on the relevant individual, team and firm. Nominations may not be progressed or may be withdrawn from all aspects of the awards at the absolute discretion of RICS if continuing with the nomination could damage public confidence in the Awards, RICS or the profession.

Nominees must disclose any information that could reasonably be considered to damage public confidence in the Awards, RICS or the profession. Examples include but are not limited to disciplinary findings, or ongoing regulatory investigations or court proceedings.

Privacy

Information provided within the submission may be used by RICS for the purpose of the judging or promotion of the Awards. Any confidential information must be clearly stated within the submission.
