

Cyprus Property Price Index Q4 2020 Prices as at 31/12/20

This is the forty-third publication of RICS' Cyprus Property Price Index, a quarterly price and rental index which is based on methodology produced by the University of Reading, UK. The Index tracks property and rental prices across all districts and main property types.

Across Cyprus, residential prices for both houses and apartments decreased on a quarterly basis by -0.61% and -0.19% respectively, with the biggest decreases being in Limassol for apartments, -0.4%, and in Larnaca for houses, -2.22%.

Values for holiday homes on a quarterly basis across Cyprus decreased by -2.85% for apartments and -1.46% for houses. Larnaca showed the largest quarterly decrease for holiday apartments with a decrease of -4.44% and Limassol showed the largest quarterly decrease for holiday houses with a decrease of -2.41%.

Across Cyprus, on an annual basis, prices decreased by -1.1% for apartments, -2.2% for houses, -6.1% for retail, -7.8% for warehouses, -2% for offices, -8.1% for holiday apartments and -4.8% for holiday houses.

Introduction & Commentary

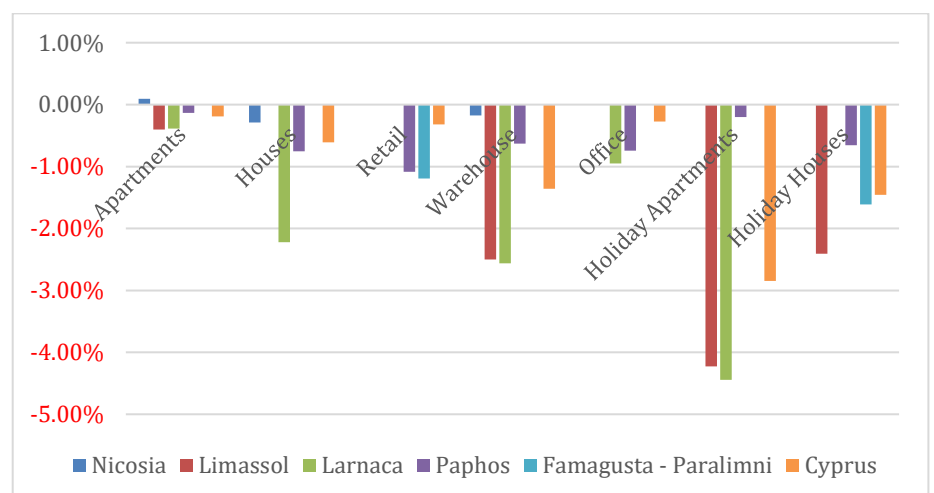
During the fourth quarter of 2020, the Cyprus economy continued to rebound compared to the previous quarter, with a seasonally adjusted quarterly GDP change of 1.4% but still presented an annual decline with an annual seasonally adjusted GDP change of -4.5%. While a slight quarterly increase was observed, the effects of COVID-19 are still apparent when viewing the annual statistics.

The number of registered contracts of sale increased by 16% from the previous quarter and decreased by -23% compared to previous seasonal year. The number properties sold to foreigners (Non-EU) with registered contracts of sale increased by 28% compared to the previous quarter, and compared to the previous seasonal year the number of contracts of sale decreased by -37.9%. The issue of NPLs and DFAS by most banks continues to be present in the market.

Market Capital Values

The Property Price Index has recorded overall decreases on an annual basis. Paphos and Limassol recorded decreases in all asset classes, whereas other cities vary, with residential assets remaining the most stable and office, retail and warehouse assets mostly showing an annual decrease.

Market Rental Values

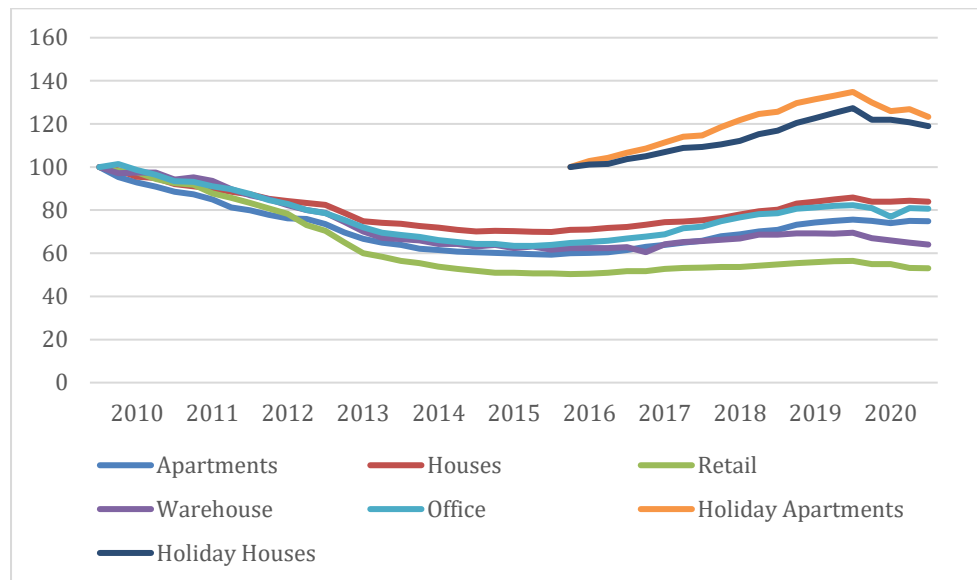
Across Cyprus, on a quarterly basis rental values increased by 0.31% for apartments and 0.01% for holiday apartments, and decreased by -0.27% for houses, -1.68% for retail, -0.61% for offices, -0.62% for warehouses and -2.02% for holidays houses.

On an annual basis, rents increased by 0.5% for offices, and decreased by -1.8% for apartments, -1.8% for houses -5.6% for retail, -1.4% for warehouses, -7.3% for holiday apartments and -6.2% for holiday houses.

Appraisal based initial yields

At Q4 of 2020 average gross yields stood at 4.8% for apartments, 2.5% for houses, 5.7% for retail, 4.5% for warehouses, 5.1% for offices, 4.9% for holiday apartments and 2.6% for holidays houses.

Index parameters and methodology

Methodology

The methodology underpinning the RICS Cyprus Property Price Index was developed by the University of Reading, UK. The report is available upon request at ricscyprus@rics.org

Coverage and Variables Monitored

The RICS Cyprus Property Price Index monitors the urban centres of Nicosia, Limassol, Larnaca, Paphos and Paralimni-Famagusta. The Index only tracks prices in Republic of Cyprus' government controlled area and not in the occupied North.

In each of these centres, the index monitors the Market Value and Market Rent, as defined in the RICS Red Book, across the four main property sectors – office (CBD), retail (high street), industrial (warehouse) and residential (houses and apartments).

Recognising that there are sub-districts within these urban areas which operate and behave in a varying manner, a number of these are monitored in order to derive the composite index for each category per urban area.

The information provided in this publication is based on the average price and rent of the sub-districts monitored per urban centre per sector. The complete list of these sub-districts can be found in the University of Reading's report which is available upon request at ricscyprus@rics.org

Nature of Notional Buildings

The RICS Cyprus Property Price Index monitors hypothetical or notional buildings, each having specific characteristics. Details of these hypothetical properties are provided in the University of Reading's report.

The provided price per sqm is based on the Gross External Area of the property (as defined in the RICS' Code of Measurement Practice 8th Edition), which includes the living area and covered verandas but excludes common areas.

Frequency

The index is produced on a quarterly basis.

Monitoring Process

The estimation of price levels is carried out by accredited RICS property professionals who are active in the relevant markets.
