



April 2018: Hong Kong Residential Market Survey

Expectations for rising interest rates not weighing on optimism

- Fundamental supply-demand imbalance continues to provide support to both prices and rents
- Respondents reported tighter credit for the second consecutive month, see tighter conditions ahead
- However contributors' outlook for prices and rents over next three and twelve months point to further gains

The April Hong Kong Residential Market Survey shows a continuation in positive momentum in the housing market. The Confidence Index increased to 44 in April from 31 in March, as a rebound in short-term price and sales expectations in New Territories and Kowloon offset a modest slowdown in positive momentum on Hong Kong Island.

Chart 2 shows that respondents reported robust price growth as headline prices (in net balance terms) held near cyclical highs. Chart 12 shows that contributors continued to report demand growing at a faster pace than supply (in net balance terms). This follows GDP growing at the fastest pace in seven years in Q1 (4.7% y/y in Q1 vs 3.4% in Q4), buoyed by a pickup in private consumption and exports.

There are signs that this pickup in economic activity may be waning. The effects of credit controls on the mainland Chinese economy are expected to begin to show up in the official data, which will likely weigh on Hong Kong's economy. Indeed, the Nikkei Hong Kong PMI has indicated a modest pullback in activity to start the second quarter.

Respondents also indicated that the economic

environment may be slightly more difficult moving forward. In net balance terms, contributors reported tighter credit conditions in April for the second consecutive month, an indication that Hong Kong banks' are passing on higher wholesale funding costs on to borrowers. Additionally, as shown in Chart 14, a majority of respondents (in net balance terms) see credit conditions continuing to tighten over the next quarter.

However this does not appear appear to have significantly dented expectations for the housing market. As shown by Charts 4, 5, and 6 respondents continue to see home prices and sales volumes continuing to rise over the next quarter, and year. Chart 9 shows that headline price forecasts remain above the three-month-moving-average.

Conditions in the lettings market continue to point to further increases in rents, as growth in tenant demand outpaces that of the supply of new properties to let (Chart 7), while contributors' 12-month rent forecasts are near or above the three-month-moving average (Chart 10). In recent months, respondents have highlighted a lack of housing affordability as supporting rents, as continued home price inflation has pushed some households completely off of the property ladder.

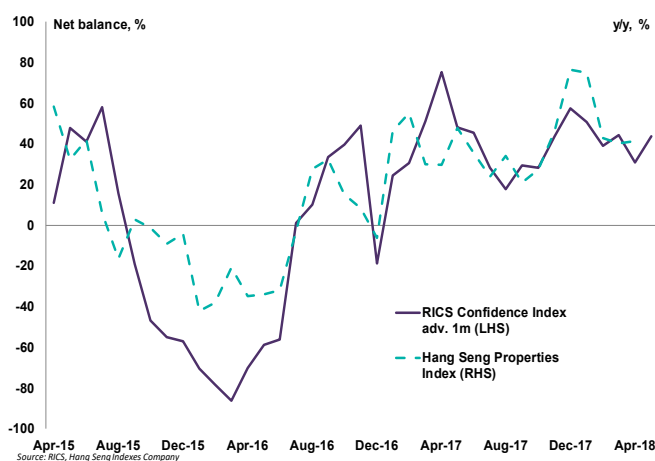
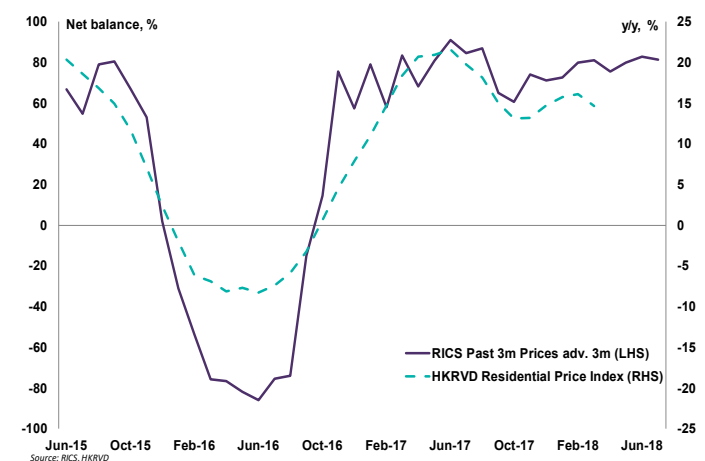


Chart 2: Prices - past month

Chart 3: Sales - past month

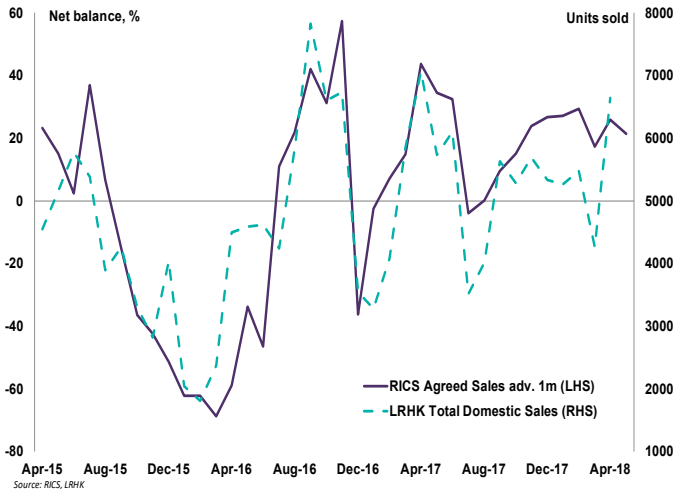


Chart 4: Price expectations - next 3 months

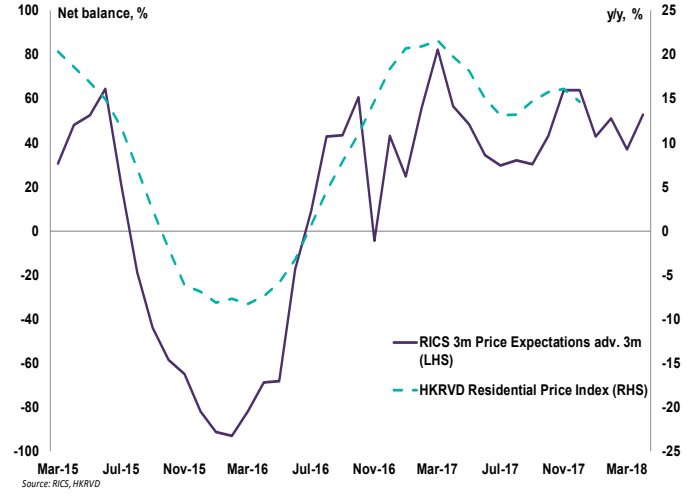


Chart 5: Sales expectations - next 3 months

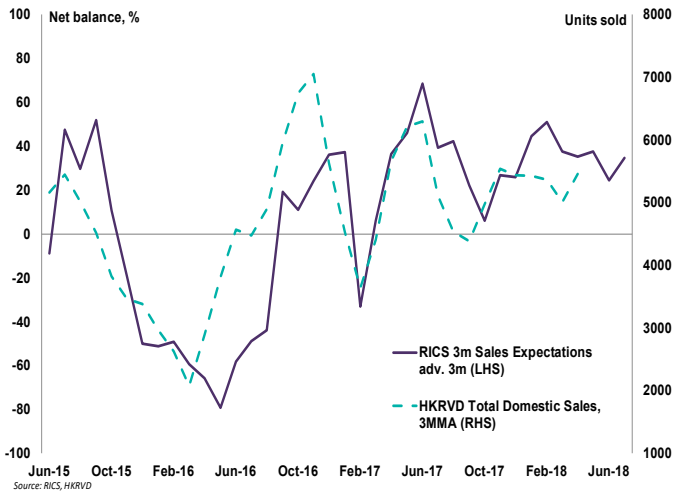


Chart 6: 12 month expectations - prices and sales

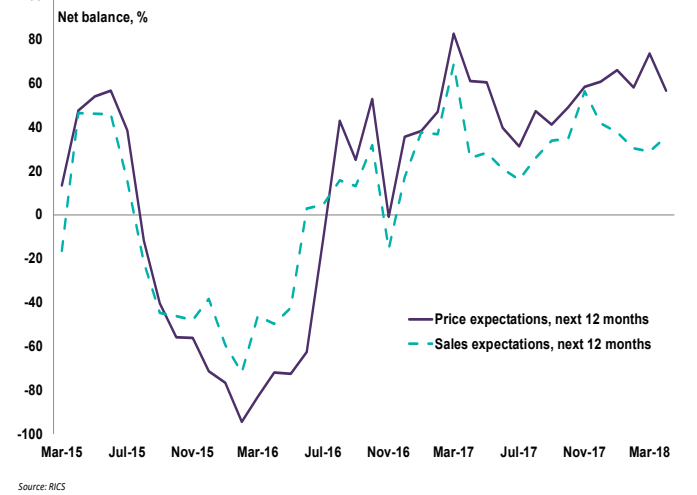


Chart 7: Tenant demand and landlord instructions - past three months

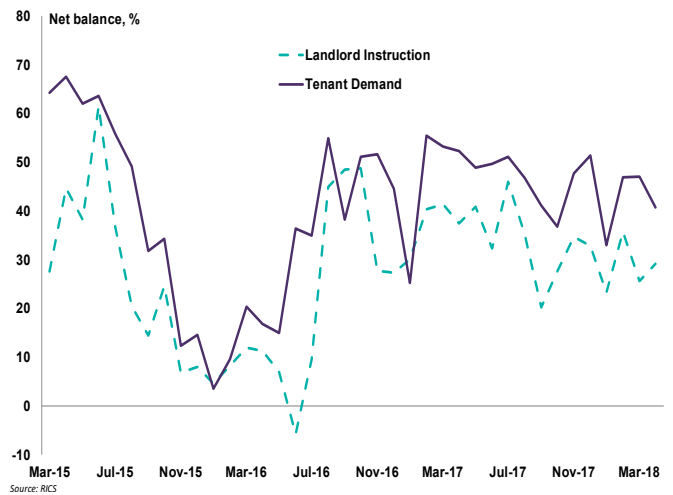
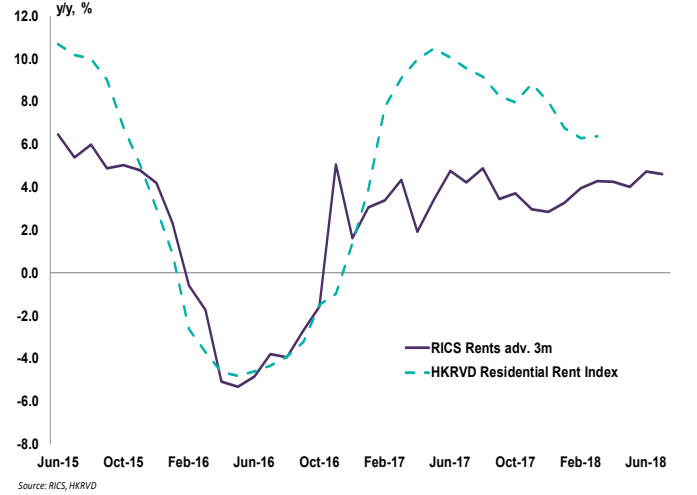


Chart 8: Past rents

Chart 9: Price forecasts - next twelve months

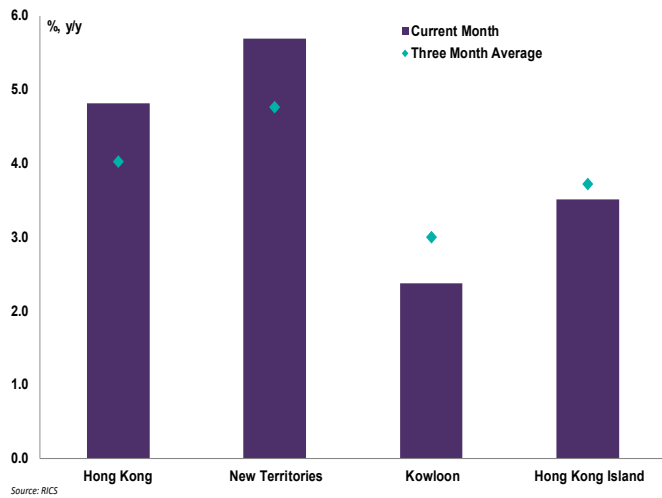


Chart 10: Rent forecasts - next twelve months

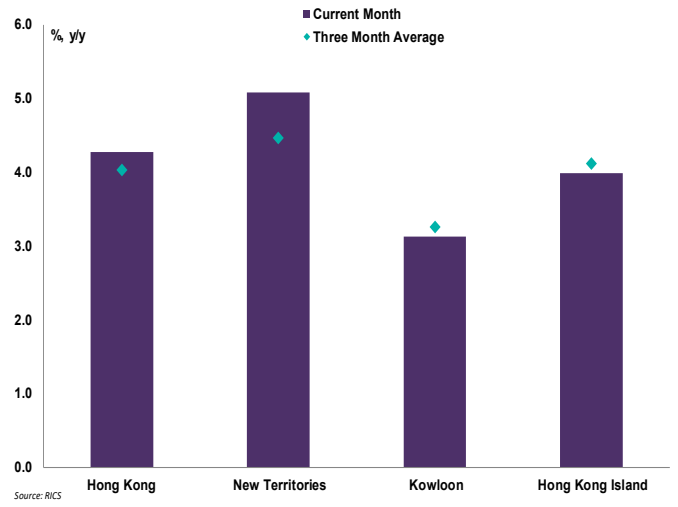


Chart 11: 12 month expectations - prices and sales

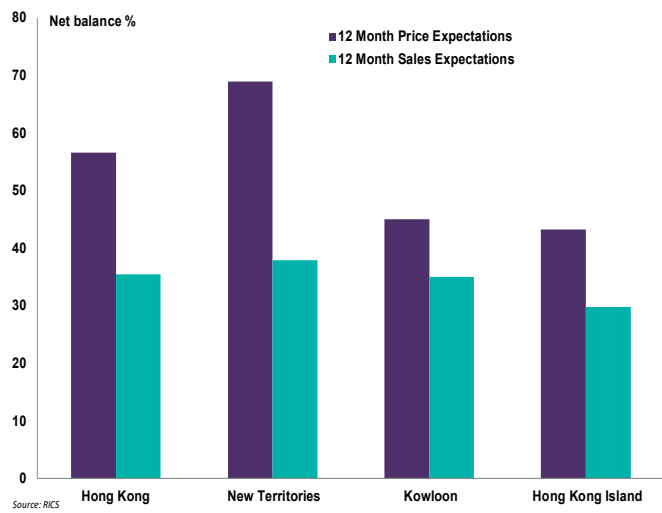


Chart 12: Instructions to sell and buyer enquiries - past month

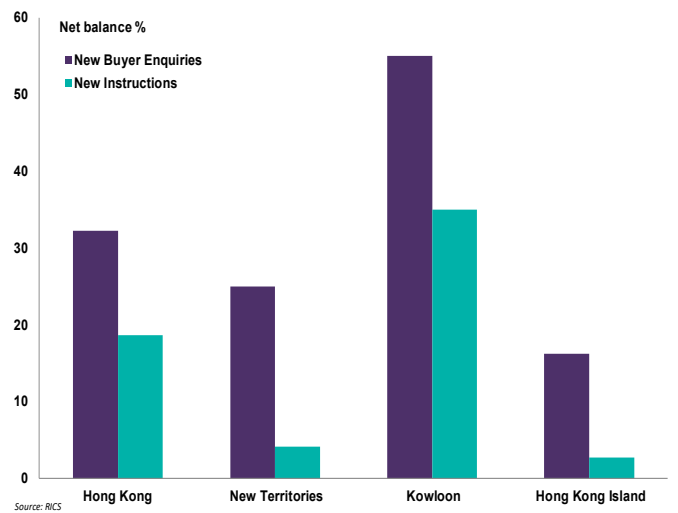


Chart 13: Buyer enquiries from mainland China

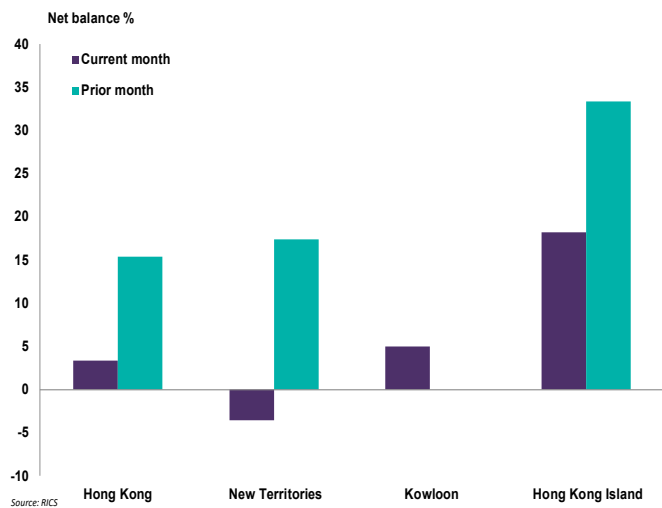
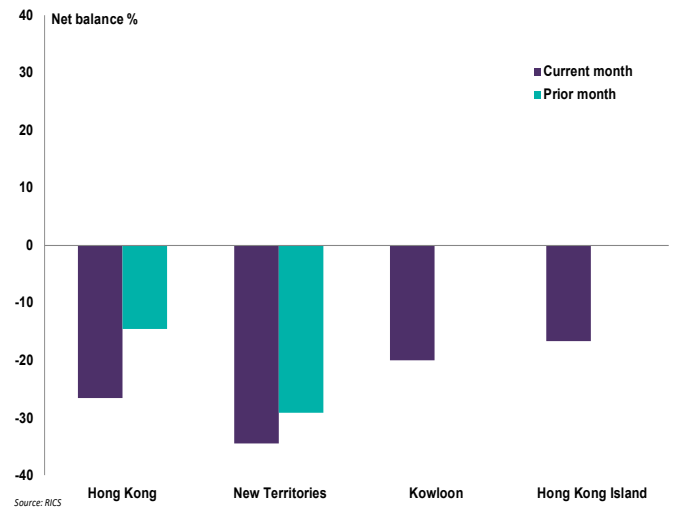


Chart 14: 3 month expectations - credit conditions

Survey Questions:

1. How have average prices changed over the last 3 months? (down/ same/ up)
2. How have new buyer enquiries changed over the last month? (down/ same/ up)
3. How have new vendor instructions changed over the last month? (down/ same/ up)
4. How have agreed sales changed over the last month? (down/ same/ up)
- 5.. How have buyer inquiries from residents of mainland China changed over the last month? (down/same/up)
6. How do you expect prices to change over the next 3 months? (down/same/up)
7. How do you expect sales to change over the next 3 months? (down/ same/ up)
8. How do you expect sales to change over the next 12 months? (down/ same/ up)
9. How do you expect average house prices, in your area, to change over the next 12 months? (% band, range options)
10. How have credit conditions changed over the past month? (deteriorated/same/improved)
11. How do you expect credit conditions to change over the next 3 months? (deteriorate/same/improve)

Definitions:

Net balance = Proportion of respondents reporting a rise in prices minus those reporting a fall. For example, if 30% of respondents report a rise and 5% report a fall, the net balance will be 25%.

The net balance measures breadth (how widespread e.g. price falls or rises are on balance), rather than depth (the magnitude of e.g. price falls or rises).

Net balance data is opinion based; it does not quantify actual changes in an underlying variable.

Net balance data can range from -100 to +100.

A positive net balance implies that more respondents are seeing increases than decreases (in the underlying variable), a negative net balance implies that more respondents are seeing decreases than increases and a zero net balance implies an equal number of respondents are seeing increases and decreases.

Therefore, a -100 reading implies that no respondents are seeing increases (or no change), and a +100 reading implies that no respondents are seeing decreases (or no change).

In the case of the RICS price balance, a reading of +10 should not be interpreted as RICS saying that house prices are going up by 10%, but that 10% more surveyors reported increases rather than decreases in prices (over the last three months).

A change from +30 to +60 does not mean that the variable grew by 30% in one period and by 60% in the next period, but it does indicate that twice as many surveyors reported an increase compared to a decrease than in the previous period.

Likewise, if we get a reading dropping from +90 to +5, this still means that more respondents are reporting increases than decreases overall, but the breadth of those reporting increases has fallen dramatically; meanwhile, a shift in the reading from -90 to -5 still means that more respondents are reporting decreases than increases overall, but the breadth of those reporting decreases has fallen dramatically.

Regions:

- National (headline) data are a regionally-weighted aggregation of three regions: New Territories, Kowloon and Hong Kong Island.

Seasonal adjustments:

- Data is not seasonally adjusted.
