RICS EWAS - UK is a voluntary service that sets the standards for chartered surveyors who act as expert witnesses.

EWAS is designed to raise standards in a sector that has not previously been subject to professional regulation. It will set universal standards for expert witnesses across the property and built environment sector.

The service is open to all property professionals and underpinned by a dedicated training course and the RICS regulatory regime.

RICS Registered Expert Witness category is available to those who have fulfilled the RICS DRS criteria, but do not have the full experience required for the Accredited Expert Witness category.

This list should be used by those who may be looking for a less experienced expert witness or by those who, for some other reason, may not want to appoint an expert witness from the Register of RICS Accredited Expert Witnesses.

The names appearing on this list are expert witnesses who have successfully completed:

- the RICS Expert Witness Certificate (or receive an exemption from the RICS Expert Witness Certificate)
- the assessment of all five competencies of the RICS Expert Witness Certificate
- the online RICS ethics test Free Ethics Walkthrough
